

SHOP & SPIN AT ASHMORE CITY - COMPETITION TERMS & CONDITIONS

- 1. Shop & Spin at Ashmore City will run on Wednesday 5 November, Wednesday 12 November, Wednesday 19 November and Wednesday 26 November from 10:00am to 1:00pm each day.
- 2. To participate, customers must spend \$10 or more in one transaction at any specialty store or \$30 or more in one transaction at Drakes Supermarket. Receipts must be dated the same day to participate.
- 3. Receipts must be presented at the Spin & Win Wheel, located outside Drakes Supermarket during promotional hours to participate.
- 4. One spin per customer, per minimum spend. Valid Tax Invoice/Receipt can only be used once.
- 5. Prizes are available while stocks last and are distributed at random.
- 6. Total Prize pool is valued at up to \$8,000 across the promotional period.
- 7. Prizes included a mix of Retailer Gift Vouchers and Items at varying values and quantities. Prize pool also includes \$5 OFF, \$10 OFF and \$15 OFF Gift Vouchers for use at participating specialty retailers.
