2. To participate, customers must spend \$10 or more in one transaction at any specialty store or \$30 or more in one transaction at Drakes Supermarket. Receipts must be dated the same day to participate.
3. Receipts must be presented at the Spin & Win Wheel, located outside Drakes Supermarket during promotional hours to participate. To be valid receipts must be printed and originals, no duplicate receipts, online receipts or bank statements are accepted.
4. Valid Tax Invoice/Receipt can only be used once. One spin per customer, per minimum spend.
